

Official Rules

Richmond Branch Retirement Giveaway Sponsored by Call Federal Credit Union (CFCU)– June 1, 2026, through June 26, 2026.

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN

ELIGIBILITY: Must be a member to enter. Call Federal’s Richmond Branch Retirement Giveaway is open to legal residents of the United States who are eighteen (18) years of age or older at the time of entry. Employees and Official Family of Call Federal Credit Union, as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee or Official Family of Call Federal Credit Union are not eligible to participate in the giveaway.

Duplicate entries will be removed. No entries will be accepted outside of the specified entry period for each entry method. DRAWING - WINNER SELECTION AND NOTIFICATION: The following business day ending the drawing period, June 29, 2026, the sponsor will select five (5) potential winners and attempt to notify them through their preferred contact method as indicated in the completed form. If the sponsor is unable to directly contact the winners within 3 business days of the drawing, the sponsor may draw another potential winner until the prize has been awarded or the sponsor discontinues the giveaway in its sole discretion.
