

Official Rules

Youth Coloring Challenge Giveaway Sponsored by Call Federal Credit Union.

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN

ELIGIBILITY: Call Federal's Youth Coloring Challenge Giveaway is open to legal residents of the United States who are eighteen (18) years of age or older at the time of entry. DRAWING - WINNER SELECTION: Within 10 business days following the ending of the drawing period the sponsor will select one (1) winner and attempt to notify the parent or guardian through contact information provided on the entry form. If the sponsor is unable to directly contact the winners within 3 business days of the drawing, the sponsor may draw another potential winner until the prize has been awarded or the sponsor discontinues the giveaway in its sole discretion. The odds of being selected depend upon the number of eligible entries received.
