

## **Official Rules**

# **System Upgrade Quiz + Drawing Sponsored by Call Federal Credit Union (CFCU)– June 25, 2026, through July 31, 2026.**

### **NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN**

**ELIGIBILITY:** Must be a member to enter. Call Federal’s System Upgrade Quiz + Drawing is open to legal residents of the United States who are eighteen (18) years of age or older at the time of entry. Employees and Official Family of Call Federal Credit Union, as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee or Official Family of Call Federal Credit Union are not eligible to participate in the giveaway.

**SPONSOR:** System Upgrade Quiz + Drawing is sponsored by CFCU. Main office located at 4235 Innslake Drive, Glen Allen, VA 23060.

**ENTRY PERIOD:** Entries will be accepted starting at 9:00 am EST on Thursday, June 25, 2026 until 6:00 pm EST Friday, July 31<sup>st</sup>, 2026, via completed online form.

**HOW TO ENTER:** To enter, the entrant must complete the online form available at [callfederal.org/upgrade-win](http://callfederal.org/upgrade-win). One entry per member. Duplicate entries will be removed. No entries will be accepted outside of the specified entry period for each entry method.

**DRAWING - WINNER SELECTION AND NOTIFICATION:** The following business day ending the drawing period, August 4<sup>th</sup>, 2026, the sponsor will select five (5) potential winners and attempt to notify them through their preferred contact method as indicated in the completed form. If the sponsor is unable to directly contact the winners within 3 business days of the drawing, the sponsor may draw another potential winner until the prize has been awarded or the sponsor discontinues the giveaway in its sole discretion. The odds of being selected depend upon the number of eligible entries received.

**PRIZE:** A \$100 deposit into their Call Federal Credit Union Primary Savings account. Deposit will be completed within 15 business days following notification of winner.
