HOW TO ENTER: To enter, complete an entry form and place in the entry box provided during the stated entry period (dates/times/ locations listed above). Wilkinson, 4605 Commerce Road, Richmond, VA 23234. **There is a limit of one entry per person throughout the event.** All mail entries must be received by 5:00 pm Monday, September 25, 2017. No entries will be accepted outside of the specified entry period for each entry method.

DRAWING - WINNER SELECTION AND NOTIFICATION: A random drawing from all entries received during the entry period will be held within 5 business days after the final shred event. The sponsor will select one (1) potential winner and attempt to notify them through contact information provided on the entry form. If the sponsor is unable to directly contact the winner within 3 business days of the drawing, the sponsor may draw another potential winner until the prize has been awarded or the sponsor discontinues the giveaway at its sole discretion. The odds of being selected depend upon the number of eligible entries received.
